## WHERE DO I PAY MY TAXES?

To pay your **first** installment tax payments (due by Jan. 31, 2015):

- In person, at **clerk's office** during regular business hours and on Thursday, December 31<sup>st</sup> from 9 am to Noon.
- **By mail.** PO Box 88, Adell. If you would like a receipt, you must enclose a self-addressed stamped envelope.
- At **National Exchange Bank & Trust in Adell**, during regular business hours or use night drop-box. If you would like a receipt, you must enclose a self-addressed stamped envelope.

To pay your **second** installment tax payments (due July 31, 2015):

- By mail to the **county treasurer's office**. Address is printed on your tax bill. If you would like a receipt, you must enclose a self-addressed stamped envelope.
- In person, at the county treasurer's office.

**Please do not send your second installment to the town clerk's office.** Any 2<sup>nd</sup> installment payments will be returned to the sender. Thank you for your cooperation! ❀

## DOG LICENSES



- Spayed/Neutered \$6
- Not Spayed/Neutered \$13

State statutes require that all dogs five (5) months of age or older need to be vaccinated against rabies and licensed each year. To obtain a license for your dog, please mail to the clerk, or bring in person:

1. A current copy of the dog's rabies certificate (not a receipt from your vet showing that a vaccination was administered), and
2. A check or cash for the payment of the license. If paying by check, please write it separately from your tax payment.

Licenses issued after March 31<sup>st</sup> will include a \$10 late fee charge. ❀

## VOTER ID NOW REQUIRED!

### Do I have the right photo ID?

These are acceptable for voting purposes and can be unexpired or expired after the date of the most recent general election (currently, Nov. 4, 2014):

- ✓ Wisconsin DOT-issued driver license
- ✓ Wisconsin DOT-issued identification card
- ✓ Military ID card
- ✓ U.S. passport

These photo IDs are also acceptable for voting purposes but must be unexpired:

- ✓ Certificate of naturalization issued within the last two years
- ✓ Unexpired Wisconsin driver license or identification card receipt
- ✓ Photo ID issued by a Wisconsin accredited university or college containing date of issuance, student signature and expiration date no later than two years after date of issuance, along with a separate document proving enrollment.

### What if I don't have a photo ID?

If you are eligible to vote but do not have a photo ID, you may obtain a free ID from the Department of Motor Vehicles. Apply for the ID as soon as possible. You will not receive it immediately; it will be sent to you in the mail.

### Do I need a photo ID to absentee vote?

#### Absentee Ballot Requests

Requests for ballots sent by mail or email must be accompanied by a photocopy of an acceptable form of voter ID. You will not need to do this with future requests, as long as you have not changed your name or address.

#### In-person Absentee Voting

If you are casting an absentee ballot in the municipal clerk's office, you must present a photo ID, just as you would at the polls.

Are there exemptions?

Photo ID is not required for the following absentee voters:

- ✓ Military voters
- ✓ Voters who are permanently overseas
- ✓ Confidential voters
- ✓ Indefinitely confined voters
- ✓ Nursing home residents whose ballots are delivered by special voting deputies
- ✓ Residents of care facilities who are not visited by special voting deputies ❁

**Building permits**, electrical permits, plumbing permits and HVAC permits are required. Please call Building Inspector Walt Grotelueschen at 262/675-0909, or download from the website.

**Diggers Hotline** - Call 811 or 1-800-242-8511 or [www.diggershotline.com](http://www.diggershotline.com) BEFORE YOU DIG. This service is free of charge. The Hotline is open 24 hours a day, 7 days a week, 365 days per year.

**Dog Licenses** - Dog licenses expire December 31 of each year. Licenses obtained after March 31 will be charged a \$10 late fee in addition to the license fee of \$6 for neutered or spayed dogs and \$13 for unneutered or unsprayed dogs. You **MUST** bring in a rabies certificate in order to obtain a dog license. REMEMBER: as a pet owner you have the responsibility to license, have vaccinated, and keep control and pick-up after your pet. Failure to do any of the above is a violation of State and Local laws and is subject to fines.

**Election Forms** – If you need to register to vote, or apply for an absentee ballot for an upcoming election, DO NOT WAIT! Contact the clerk at 994-9421 or download those forms from the website. Click on “Election Information”.

Most **Electronics** MAY NOT be put in the trash. E-Cycle Wisconsin helps you find a place to recycle your old electronics. Google “E-Cycle Wisconsin” for details.

**Notary Service** is available to Town residents during regular office hours. Bring your Driver’s License along to verify your signature and do not sign the document ahead of time.

**Public Notices** - Agendas are posted the Silver Creek Fire Hall (front of building), and on the town’s website at least 24 hours in advance of the meeting. The Sounder is the official newspaper of the Town of Sherman.

**Snow Plows** - Please stay back at least 500’ from snowplows. They are unable to see you due to the blowing snow.

**Town Clerk’s Hours** – Monday, Tuesday, and Wednesday: 2 pm to 4 pm

**Zoning** – The complete zoning map and ordinance can be found on the website, or you may contact the clerk with questions regarding your specific zoning. ❁
