<p><b>What are examples of government agencies who can issue Proof of Residence documents?</b></p>	<p><b>THIS IS NOT A COMPREHENSIVE LIST. THESE ARE ONLY EXAMPLES OF UNITS OF GOVERNMENT.</b></p> <p>Government agencies can include local, state, or federal units of government.</p> <ul style="list-style-type: none"> <li>➤ Local units of government include: city, town or village clerk or treasurer’s office, your county clerk or treasurer, and many others.</li> <li>➤ State units of government include: Division of Motor Vehicles (DMV or DOT), Department of Natural Resources (DNR), Department of Workforce Development (DWD), Department of Human Services, and many others.</li> <li>➤ Federal units of government include: Internal Revenue Service (IRS), Medicare (not second party vendors), Social Security, and many others.</li> </ul>
<p><b>What are examples of Proof of Residence documents issues by a government agency?</b></p>	<p><b>THIS IS NOT A COMPREHENSIVE LIST. THESE ARE ONLY EXAMPLES OF PROOF OF RESIDENCE DOCUMENTS.</b></p> <ul style="list-style-type: none"> <li>➤ Fishing and hunting licenses</li> <li>➤ Vehicle registrations</li> <li>➤ Food stamps, Wisconsin Works, Wisconsin Shares, and BadgerCare notices and correspondence</li> <li>➤ Medicare notices and Medicare Explanation of Benefits (not from 2<sup>nd</sup> party providers or other health insurance providers)</li> <li>➤ Social Security and SSI notices and benefits statements</li> <li>➤ Public high school, technical college, and public university correspondence and documents, including: admissions correspondence, financial aid notices, report cards, and schedules</li> <li>➤ Federal student loan correspondence and notices</li> <li>➤ Billing statements and collection notices from a governmental entity</li> <li>➤ Correspondence from a federally recognized Native American Tribe living in Wisconsin.</li> </ul>
